CEEG is a solar panel manufacturer in China. LUMOS is headquartered in Colorado and sells solar energy products to consumers. On June 29, 2009, CEEG and LUMOS entered into a Co-Branding Agreement (the "Agreement") under which LUMOS agreed to order a certain minimum quantity of solar products from CEEG over a period of three years.

The Itimpi Solar Photovoltaic Power Station is expected to offset 122,000 tonnes of carbon emissions annually, complementing CEC's efforts to support Zambia's Nationally Determined Contribution in reducing carbon emissions.
