What is Samruk-Energy JSC?

The main activities of Samruk-Energy JSC are the management of energy assets in the Republic of Kazakhstan, as well as assistance in the modernization of existing and construction of new generating capacities, the introduction of new technologies in the energy sector of the Republic of Kazakhstan.

How much energy is produced by Samruk-Energy JSC?

The volume of electricity production by subsidiaries of Samruk-Energy JSC for 8 months of 2023 amounted to 23 billion kWh, which is 101% of the plan. The release of thermal energy amounted to 4.0 million Gcal. The volume of electricity transmission (AZHC JSC) is 5.7 billion kWh. The volume of coal sales (Bogatyr Komir LLP) is 27.7 million tons.

Who is Samruk-Energy?

"Samruk-Energy" JSC is the largest diversified electric power holding company with a primary objective of establishing a highly efficient energy supply system to support the sustainable development of all sectors in Kazakhstan.

Does Samruk-Energy JSC have a diversified portfolio?

The company has a diversified portfolio of power plants: Samruk-Energy JSC is steadily increasing the company's electricity market share in Kazakhstan from 29% in 2019 to 31% in 2021. The debt/EBITDA ratio decreased from 3.31 in 2019 to 2.41 in 2021. The company progressively increased its electricity production from 2019 to 2021.

How much coal does Samruk-Energy provide?

The total coal reserves in the warehouses of the company's thermal power plants are provided with 791.5 thousand tons, that is, regulatory reserves are provided. The volume of electricity production by subsidiaries of Samruk-Energy JSC for 8 months of 2023 amounted to 23 billion kWh, which is 101% of the plan.
