This followed the contract award by National Grid Electricity System Operator (ESO) in November 2022, through the Stability...

The BESS project will be used to store renewable energy for flexible purposes for the grid. The facility, which is scheduled to be operational by the end of 2024, will have a total of 15 energy storage containers. Conrad Energy is also set to implement measures to demonstrate a 15.37% gain in habitat units and a 10.4% gain in hedgerow units.
