Does Russia need Belarus's energy-transit link to Europe?

Despite plans to bring the Nord Stream Two and TurkStream gas pipelines online in the near future, for now Russia continues to need Belarus's energy-transit link to Europe. This will remain the case unless major geopolitical changes envelop the region or there is regime change in Minsk or Moscow.

Why does Belarus import Russian gas?

Belarus has no domestic oil or gas reserves to speak of, but its economy is highly energy-intensive. So it has no choice but to import Russian gas, since it is the cheapest available. Russia gave Belarus a huge price discount until their first energy dispute in 2004. But Gazprom has increased the price of Belarus's supply several times since then.

Is Belarus a natural gas producer?

And while not a natural gas producer, it delivers the fuel to numerous countries via pipelines built during Soviet times. Its unique situation stems from Belarus's location next to its nearly sole energy supplier, Russia, and the fact that its economy is heavily based on these hydrocarbon resources.

Amidst a perfect storm of conditions leading to increased gas prices and greater demand, Russia is leveraging its role as a major energy supplier to put pressure on Europe. While Russia's energy dependence on Belarus as a transit state has decreased due to the Nord Stream and TurkStream pipelines, Belarus remains a crucial route for delivering Russian gas and oil to European buyers. In 2019, 33 billion cubic meters of gas were transported to Europe through the Yamal-Europe pipeline crossing Belarus.
