

Is Algeria a member of the European Union?

In 1976 the European Economic Community signed a treaty with Algeria, formalizing their relationship as a neighboring entities. Algeria has been in an association agreement and a free trade agreement with the European Union since 2005. In 2016, 67% of Algeria's exports went to the EU and 44% of Algeria's imports came from the EU.

Does the EU's Euro-Mediterranean association agreement with Algeria affect trade?

The impact of trade component of the EU's Euro-Mediterranean Association Agreement with Algeria was assessed in the Ex-Post Evaluation of Trade Chapters of the Six Euro-Mediterranean Association Agreements with the EU's Southern Neighbours, published by the Commission in 2021.

What will the EU and Algeria do in 2020?

A joint assessment of the implementation of the Association Agreement has been finalized in March 2017, along with the Partnership priorities: the new political framework that will guide the dialogue of the EU and its Member States with Algeria up to 2020. The EU and Algeria entertain also a high-level dialogue on energy.

What does the EU want to do with Algeria?

The EU's aim is to engage constructively with Algeria with a view to removing the restrictions on several market sectors, spanning from agricultural products to motor vehicles.

How did Algeria become a member of the EEC?

Following its independence from France in 1962, the legal status of its relationship with the EEC was unresolved, as the text of the Treaty of Rome continued to refer to Algeria by name as an overseas territory of France to which the treaty provisions applied.

The EU is Algeria's biggest trade partner and accounts for the majority of Algeria's international trade (around 50% in 2023). Total trade in goods between the EU and Algeria in 2023 amounted to EUR50.2 billion. The EU's imports from Algeria amounted to EUR35.4 billion. Imports were dominated by mineral products (EUR33.9 billion, 96%).
