Did Evergrande Group file for bankruptcy?

Is Evergrande still a real estate company?

At least until Hui was detained four months ago, the company was still active in completing and selling tens of thousands of homes across the country. Before it ran into trouble, Evergrande had more than 12,000 employees, raked in more than \$110 billion in sales, and owned more than 1,300 property developments in 280 cities.

Is Evergrande a good investment?

As China's largest issuer of high-yield dollar denominated debt, Evergrande was an attractive investment, despite known risks, because it paid annual interest rates of 7.5% to 14%. China's total debt--household, corporate, and government--reached 290% of GDP in 2020 (Figure 1), with the majority of debt held by companies.

Did Evergrande overstate its revenue in 2024?

Evergrande stated on 19 March 2024 that the China Securities Regulatory Commission (CSRC) had found that the company had overstated its revenue in 2019 by 214 billion yuan (nearly \$30 billion), or about half, and in 2020 its revenue was overstated by nearly 80%, or 350 billion yuan (\$48.6 billion).

Does Evergrande invest in China?

Evergrande's overseas presence allows it to raise and transfer funds in and out of China. Evergrande Group and three subsidiaries--China New Energy Vehicle, HengTen Networks, and Evergrande Property--are listed in Hong Kong. Its corporate bonds trade in Singapore, and it operates a wealth management business through its life insurance subsidiary.
