The demand for solar energy is skyrocketing across the nation. This is great news! However, as the solar industry grows and more companies compete for your business, you might notice an uptick in misleading solar advertisements or sales practices -- or even outright scams. (Don't get us wrong, plenty of solar ads are fine and the solar industry has many reputable providers.

You may see ads that suggest that your state has a program that will provide a solar PV system for free. According to Business Insider, which conducted an extensive investigation into misleading claims, ads on Facebook have taglines like "federal and state programs pay you to go solar." These claims are blatantly false.

The U.S. government does not provide free solar panels, an Energy Department spokesperson told PolitiFact. The Facebook post promising free solar panels links to another site with a disclaimer ...

Cold call 1: "Free health check for your solar panels" This was by far the most common cold call solar panel owners said they received, with 44 per cent having been approached about this.
