Who is eligible for solar PV panels?

To be eligible for solar PV panels, your home needs to meet these specific requirements: Have an income of less than £31,000. Currently have an inefficient heating system within the D-G energy efficiency band. Own your home and live in it, or live in private rented accommodation (requires permission from the landlord).

How much does a solar panel system cost?

Solar electricity is low carbon, renewable energy. A typical home solar panel system could save around one tonne of carbon per year, depending on where you live in the UK. That's the equivalent of driving 3,600 miles, or from London to Bristol 30 times. The average domestic solar panel system is 3.5kWp and costs around £7,000.

The free solar panel scheme was a government initiative that aimed to help homeowners install solar panels on their properties for free that worth £5,000-£11,000.
