Will Greece fund 1GW of battery storage?

It is the first round of a state-led procurement aiming to fund up to a 1GW of battery storage. The Regulatory Authority for Energy of Greece has chosen the 12 winning projects of a battery storage tender with 411MW awarded aid.

How many projects have been awarded in Greece's first battery energy storage system?

The Greek Regulatory Authority for Energy has confirmed that 411.8 MW of projects have been awarded in the country's first standalone battery energy storage system (BESS) tender, which has attracted huge interest among developers. Investment and operating aid will be granted to 12 projects put forward by seven proponents.

How many companies have won support for a battery project in Greece?

Seven companies have won support for 11 standalone battery projects at Greece's second energy storage auction.

Does Greece have a 1 GW energy storage program?

The auction is part of Greece's 1 GW energy storage program. The country announced its 1 GW energy storage program in the summer with three separate tenders featuring 400 MW, 300 MW and 300 MW of capacity. The first tender awarded 12 energy storage projects in August, with 411,79 MW of capacity in total.

How many mw can a company invest in energy storage in Greece?

The Regulatory Authority for Energy, Waste and Water (RAAEY) completed the selection process in the first energy storage auction in Greece. According to the terms of the auction, each participant could apply with a maximum of 100 MW. Three companies divided it into separate investments.

Does Greece have a battery storage pipeline?

Greece has emerged as one of the countries with the largest pipeline of battery storage projects, but as yet there has been little activity on the ground. This is changing as the long-awaited storage subsidy auctions have started, with the first projects being awarded support for both investment and operating costs.

proponents.

The renewables arm of domestic power utility PPC SA (ATH:PPC) has grabbed two projects, of 50 MW and 48 MW, respectively, and Energy Bank has secured 50 MW. A unit of Greek industrial group Mytilineos SA (FRA:MYH) has been awarded 48 MW, while local firms Energy Engineering and Energy Community won projects of 7.8 MW and 8 MW, respectively.

To date, Greece is the only EU member state to sign an agreement with the European Investment Bank to co-manage up to EUR5 billion (\$5.80 billion) of Greece's RRF. An energy storage webinar organized last year by Greece's energy regulator RAE, suggested the country would need about 1,500 to 1,750 MW of new energy storage capacity.
