How does Guam Power Authority manage performance?

Guam Power Authority management holds strongly to the tenet that if you do not measure performance, then you cannot manage performance. In order to better serve the public, the Authority maintains standards for performance. In addition, the PUC and GPA have agreed upon standards for prudent fuel use.

What is Guam Power Authority (GPA)?

Established May 1968 by the Guam Power Authority Act of 1968. See, Guam Code 12, Chapter 8. GPA is a public corporation and an enterprise fund of the Government of Guam. GPA's governing board is the Consolidated Commission on Utilities (CCU) consisting of five elected commissioners. GPA's rates are regulated by the Guam Public Utilities Commission.

What is the Guam Waterworks Authority (CCU)?

Established by law in 2002, the CCU's purpose is to exercise powers vested in them by the laws establishing the Guam Power Authority ('GPA') and the Guam Waterworks Authority ('GWA') and serves as its board of directors. The CCU is comprised of five (5) commissioners elected at-large by the voters of Guam in a General Election.

What is Guam Power Authority & Public Utilities Commission?

Guam Power Authority and the Guam Public Utilities Commission, as the result of a collaborative effort, have agreed on a set of standards, practices, procedures and methodologies to promote and provide incentives for prudent fuel use.

What is GPA doing with Guam ukudu power?

In November 2019 GPA entered into a contract with Guam Ukudu Power, LLC for the construction and operation of a 198 MW Combined Cycle Combustion Turbine Power Plant. This new power plant will allow for the retirement of its oldest plant, Cabras 1&2, and address its emission compliance issues.
