5 ; Year on year Mcphy Energy SA had net income fall 24.31% from a loss of 38.16m to a larger loss of 47.43m despite a 16.89% increase in revenues from 16.06m to 18.77m. An increase in the selling, general and administrative costs as a percentage of sales from 242.09% to 258.44% was a component in the falling net income despite rising revenues.
