

Will a new regulation on rooftop solar power plants be enacted in Indonesia?

Now a new regulation on rooftop solar power plants has been enacted with the aim of finally realizing the untapped potential for solar power in Indonesia.

How do rooftop solar power plants work in Indonesia?

For rooftop solar power plants, the most popular business scheme in Indonesia is to adopt an operating lease arrangement. A rooftop solar power plant developer leases its rooftop solar power plant equipment to a consumer, with the rental fee as the underlying tariff payment, on a contractual basis. The MEMR regulation provides further relaxation.

What are the new regulations on rooftop solar systems?

The New Regulation introduces several changes to the regulatory framework on rooftop solar systems, including: Imposing an obligation on PT PLN (Persero) Tbk.

Is Indonesia ready for solar energy?

Enthusiasm to develop solar energy is growing rapidly in Indonesia. At the Indonesia Solar Summit 2022, at least 31 parties are committed to installing solar PV with a capacity of up to 2,300 MW. The availability of cheap financing mechanisms can support the achievement of these commitments.

Is Indonesia a good place to invest in solar energy?

Despite its huge solar power potential (up to 207.8GW of potential capacity), the country still shows very low utilisation of solar energy (only 0.1 %). From a regulatory perspective, the government has set a positive momentum for investments in Indonesian renewable energy-based power generation.

How do I apply for a solar rooftop system?

Under MEMR Reg. 2/2024, applications for installing solar rooftop systems can only be submitted from January to July. The applicant will submit the standard application form to the relevant IUPTLU holder with a copy to the Director General of New and Renewable Energy and Energy Conservation. The IUPTLU holder will verify the submitted application.
