How does the SEG work?

Under the SEG, homeowners and businesses with eligible renewable energy systems, such as solar panels or wind turbines, can receive payments from their energy supplier for each unit of excess electricity they export to the grid.

How much can I get through SEG export tariffs?

How much you can get through these export tariffs varies depending on your SEG licensee. The Smart Export Guarantee scheme allows companies to decide their own rates, as long as it's more than zero. Currently, you can get between 1-30.31 p per kWh.

Do energy companies offer SEGs?

Although, the caveat is energy companies are legally obliged to offer an SEG scheme. This leads to a huge variety of tariffs and pricing, as some companies embrace the idea and offer a reasonable amount while others are very much into the monopoly they have and offer derisory amounts. So, what rates are energy companies offering for SEGs?

How much p per kWh can I get from SEG?

Currently, you can get between 1-30.31 p per kWh. It's important to note that even though you can export solar energy back to the grid at any time of day through the SEG, the payments you receive for transferring energy may differ depending on when the transfer is made.

What is the SEG scheme?

The SEG scheme is open to small-scale generators with a capacity of up to 5MW, which includes most domestic renewable energy installations. The scheme is designed to be flexible, with payment rates set by energy suppliers, allowing them to compete with each other and offer different rates to their customers.

Do solar panels qualify for a SEG tariff?

Solar panel systems are undoubtedly one of the most popular methods for generating low-carbon energy. Regardless of the kind of solar PV system you own, you qualify for the SEG tariff as long as the system creates less than 5MW of electricity.

Any Solar PV generator, whether you're a home or business, can apply for the SEG as long as they aren't receiving any other incentive, such as the old Feed-In-Tariff payments and the system isn't larger than 5MWp of capacity. Who pays you? You are free to sign up to any suppliers Smart Export Guarantee scheme.

You can qualify for the Smart Export Guarantee if you generate electricity with solar panels, small wind turbines, micro combined heat and power, hydro or anaerobic digestion. The average solar panel owner can make around £159 a year from exporting excess electricity back to the grid. If you have a smart meter, you automatically qualify for ...

The Smart Export Guarantee, often abbreviated as SEG, is a government-backed initiative in the United Kingdom designed to reward solar panel owners for the surplus electricity they generate and export to the grid. The scheme replaces the previous Feed-in Tariff (FIT) program, which closed to new applicants in March 2019.

If we take Scottish Power's SEG, which is open to anyone and pays the highest rate of all the "open" SEGs: An average 3-bedroom home, with a normal 3.5 Kw solar system can earn £159 per year at the 12p per kWh rate.
