What is the rate of tax for wind turbine generator / wind mill?

As per Notification No. 01/2017 Central Tax (Rate), dated 28.06.2017, amended vide Notification No.08/2021 Central Tax (Rate), dated 30.09.2021, the rate of tax for Wind Turbine Generator/Wind Mill has been increased from 5% to 12%(6% CGST +6% SGST) with effect from 01.10.2021. 5. How is wind power taxed?

In the case of wind power, in terms of section 12B of the Income Tax Act, 50% of the cost to acquire the asset may be deducted in the year in which the asset is brought into use, and 30% and 20% may be deducted in each of the two succeeding years, respectively.

What is the VAT rate for high power wind turbine generators?

The general VAT rate is 20%. For import of the key parts and raw materials used for production of the high power wind turbine generator systems or their components custom legislation of the Eurasian Economic Union stipulates an incentive rate 0%.

What are the tax implications of a wind turbine installation?

In particular the number of planned installations of wind turbines has increased considerably. But what are the tax implications of such an installation? Where the wind turbine is not part of a domestic installation, then the income from the turbine will be taxable.

Are wind power generation companies eligible to avail input tax credit?

Further, since the sale of electricity is exempt from GST, as per the provisions relating to availment of input tax credit, wind power generation companies are not eligible to avail input tax credit of GST paid on procurement of goods and/or services which are required to set up the wind power generation project.

What is the GST rate for used wind turbine generators & accessories?

GST Rate for Used Wind Turbine Generators and Accessories According to the rulings, the composite supply of a used WTG, including its accessories, has been taxed at a rate of 6% under both the CGST Act, 2017 and the TNGST Act, 2017.
